How to Apply:

1. Online Submission and Deadline

- Complete the application and abstract form available at www.wsperio.org no later than 11:59 PM EDT on April 2, 2026.
- Incomplete and late applications will not be considered. Please email completed materials to acollins@wsperio.com

2. Review Process

- All submissions will be reviewed by the WSP Conference Committee for relevance, clarity, and quality. Applicants will be notified of acceptance or rejection by April 20, 2026. Please refrain from contacting WSP about application status before this date.

3. One Submission per Applicant

- Only one application per primary (main) author will be accepted.

4. Presentation Categories

- Clinical Case:** A detailed report of a patient's presentation, diagnosis, treatment, and follow-up.
- Research (Basic Science or Clinical):** A structured investigation involving data collection, analysis, and hypothesis testing.

5. Abstract Requirements

a. Case Report Abstracts must include:

- Rationale and clinical significance of the case
- Diagnosis and etiology
- Treatment approach and outcomes
- Conclusions (must be complete and final)

b. Research Abstracts must include:

- Objectives
- Materials and Methods
- Results (include relevant data and statistics)
- Conclusions (must be complete and final)

6. Acknowledgment of Financial Support

- If applicable, please disclose any financial support (including funding source, amount, and grant number).

7. Confidentiality Statement

- By submitting, applicants confirm that all information provided is free of confidentiality restrictions and may be publicly discussed and disseminated without limitation
